













# Schemes Quick Reference Guide

When scheme logos are included on a pedigree in this catalogue what do they mean?

	<p>The lot is sired by a BOBS eligible stallion and is eligible to nominate to the BOBS scheme but the horse is not yet nominated.</p> <p>To be eligible for BOBS Silver bonuses when racing the horse as a 2YO and 3YO in NSW, owners are required to nominate for BOBS and pay the prescribed fee by 1 September of the lot's 2YO year. Note: this deadline is extended to 30 October 2024 limited to 2YOs offered at the Magic Millions Horses in Training Sale.</p> <p>BOBS Double-Up vouchers can be redeemed towards the purchase of this lot.</p> <p>The BOBS scheme is administered by Racing NSW.</p>
	<p>The lot is nominated to BOBS Silver and is eligible to win BOBS Silver bonuses when racing the horse as a 2YO and 3YO in NSW, with no further action required.</p> <p>The BOBS scheme is administered by Racing NSW.</p>
	<p>The first payment of the QTIS registration has been processed for the lot but the horse is not yet fully registered.</p> <p>To be eligible for QTIS bonuses when racing the horse in Queensland, owners are required to complete the QTIS nomination and make the final payment of the prescribed fee by 30 June of the lot's 1YO year (or make late payment by 31 August of the lot's 1YO year).</p> <p>The lot is eligible for QTIS under Eligibility B criteria, whereby the dam of the horse was covered by a Queensland domiciled stallion in the year this lot was born.</p> <p>QTISx vouchers can be redeemed towards the purchase of this lot.</p> <p>The QTIS scheme is administered by Racing Queensland.</p>
	<p>The lot is fully paid up and eligible to win QTIS bonuses when racing the horse in Queensland, with no further action required.</p> <p>If the lot is sired by a stallion which was standing in Queensland at the time of conception, the horse is automatically fully paid up to the scheme free of charge, with no payment or nomination paperwork required.</p> <p>QTISx vouchers can be redeemed towards the purchase of this lot.</p> <p>The QTIS scheme is administered by Racing Queensland.</p>
	<p>The lot is nominated to Racing Rewards SA and eligible to win Racing Rewards SA bonuses when racing the horse in SA, with no further action required.</p> <p>The Racing Rewards SA scheme is administered by Racing SA.</p>
	<p>The lot is nominated to TASBRED and eligible to win TASBRED bonuses when racing the horse in Tasmania, with no further action required.</p> <p>The TASBRED scheme is administered by Tasracing.</p>
	<p>STATUS – Paid up for VOBIS Silver.</p> <p>ON OFFER – Race for VOBIS Silver Bonuses on all Victorian 2YO &amp; 3YO TAB races &amp; maidens 2000m+.</p> <p>BONUS – Bonuses paid to Nominator, Owner, Trainer &amp; Jockey: 1st, 2nd &amp; 3rd in VOBIS Silver races.</p> <p>UPGRADE – Upgrade to VOBIS Gold, race for additional prizemoney &amp; bonuses. Upgrade by 30th Nov 2024.</p> <p>The VOBIS scheme is administered by Racing Victoria.</p>

	<p>STATUS – Progeny of a VOBIS Sires nominated stallion.</p> <p>REDEEM – This lot can be purchased with VOBIS Platinum vouchers, once nominated to VOBIS Silver.</p> <p>NOMINATE – to VOBIS Silver, race for VOBIS Silver Bonuses on all Victorian 2YO &amp; 3YO TAB races &amp; maidens 2000m+.</p> <p>UPGRADE – Upgrade from VOBIS Silver to VOBIS Gold, straight to VOBIS Platinum. Upgrade by 30th Nov 2024.</p> <p>RACES – Once upgraded, eligible for VOBIS Gold Prizemoney &amp; Bonuses, the VOBIS Platinum Showdown &amp; VOBIS Platinum Guineas, plus VOBIS Platinum vouchers on 250+ VOBIS Gold races.</p> <p>The VOBIS scheme is administered by Racing Victoria</p>
 + 	<p>STATUS – Progeny of a VOBIS Sires nominated stallion and paid up for VOBIS Silver.</p> <p>REDEEM – This lot can be purchased with VOBIS Platinum vouchers.</p> <p>ON OFFER – Race for VOBIS Silver Bonuses on all Victorian 2YO &amp; 3YO TAB races &amp; maidens 2000m+.</p> <p>BONUS – Bonuses paid to Nominator, Owner, Trainer &amp; Jockey: 1st, 2nd &amp; 3rd in VOBIS Silver races.</p> <p>UPGRADE – Upgrade from VOBIS Silver to VOBIS Gold, straight to VOBIS Platinum. 	<p>The lot is breeder nominated to the Westspeed Standard scheme but not yet owner nominated.</p> <p>For the owner/s to be eligible for Westspeed Standard bonuses when racing the horse in WA, owners are required to complete the owner nomination and pay the prescribed fee by the prescribed July deadline of the lot's 1YO year.</p> <p>The lot is eligible for Westspeed under the criteria whereby the dam of the horse was at least 50% owned by a WA based breeder at the time of conception (as recorded in the Australian Stud Book); OR the dam of the horse was covered by a WA domiciled stallion in the year this lot was born.</p> <p>The Westspeed scheme is administered by Racing WA.</p>
	<p>The lot is breeder nominated to the Westspeed Platinum scheme but not yet owner nominated.</p> <p>For the owner/s to be eligible for Westspeed Platinum bonuses when racing the horse in WA, owners are required to complete the owner nomination and pay the prescribed fee by the prescribed July deadline of the lot's 1YO year.</p> <p>The lot is sired by a Westspeed Platinum nominated stallion, which was standing in WA at the time of conception.</p> <p>Westspeed Platinum owner nominated horses are eligible for substantially higher (double) bonuses compared to Westspeed Standard, as well as being eligible to compete in Westspeed Platinum Restricted Races.</p> <p>The Westspeed scheme is administered by Racing WA.</p>
